Consultancy: Deliver sector wise training for Monitoring, Reporting and Verification (MRV) system and Sri Lanka Carbon Registry (SLCR)

The Climate Mitigation Action Support Project intends to call Expression of Interest (EOI) from qualified and interested national consultancy firms for the above consultancy.

This consultancy is procured under the CMASP which is a grant (No. TF0B0017) of the Partnership for Market Readiness (PMR) Secretariat under the World Bank.

The Ministry Consultant Procurement Committee on behalf of the Climate Mitigation Action Support Project now invites eligible consultancy firms to express their interest in providing the services described herein. Interested consultancy firms must provide information indicating that they are qualified and experienced to perform the aforementioned consultancy.

The consultancy firm first needs to understand the deployed MRV system and SLCR in detail using the system specifications documents, user manuals and interaction with the system developers. The consultancy firm also requires to assess the training needs and develop training modules to conduct customized training programs for identified stakeholders as described in the ToR. The period of the consultancy is 22 weeks.

EOI should include the following information relevant to the consultancy:

- **Experience of the firm and team of experts in climate change and global warming, source of GHG emissions, GHG activity data identification and collection, GHG inventory preparation or carbon footprint analysis, GHG mitigation in various sectors in Sri Lanka**
- **Experience of the firm and team of experts in identification of technical and institutional capacity needs, conducting comprehensive training and capacity building programs**
- **Academic/professional qualifications of team of experts in environment science, management, engineering, agriculture, science or other relevant discipline**

- **Profile of the consultancy firm including scope of the services/business, legal status, administrative and financial capacity, etc.,
(team of expert should submit resumes with their experience, academic/professional qualifications and other supportive information fulfilling the requirement given in the ToR)**

Consultants will be selected in accordance with the procedures set out in the Guidelines for Selection and Employment of Consultants, published by the National Procurement Agency following Selection of Consultant's Quality and Cost Based Selection (QCBS) method.
